1. Parental allowance

After the birth of a child, previously working parents have the opportunity to forego or limit their employment in order to devote themselves to the care and support of their baby. The basic parental allowance compensates for the net income lost after the birth at a fixed percentage for up to 14 months.

2. Bavarian family money

Since September 1, 2018, the Bavarian family allowance has given special recognition to the parenting efforts of parents with small children. Parents should be given economic leeway in their decisions regarding upbringing, education and health promotion.

3. Child benefit, child allowance & child allowance

Child benefit and child allowance are federal benefits that provide financial support to parents. The child allowance is one of the tax reliefs for families.

4. Bavarian crèche allowance

Since January 1, 2020, parents have been granted childcare allowance relief of up to 100 euros per month per child from their child's first birthday if they actually pay them. In addition to parents, adoptive foster parents and foster parents can also benefit from daycare allowance. The crèche benefit requires that the child is cared for in a facility funded under the Bavarian Child Education and Care Act (BayKiBiG) or that the childcare relationship in day care is supported in accordance with the BayKiBiG.

The crèche allowance is only paid to parents whose income does not exceed a certain income limit. This is intended to specifically support parents in the middle and lower income ranges.

The crèche allowance can be applied for at the responsible regional offices of the Bavarian Family and Social Center (ZBFS).

5. Child sickness benefit

Working parents can take time off work free of charge for a certain period of time in order to ensure that they can look after their sick child themselves. Parents who have statutory health insurance can apply for child sickness benefit from their health insurance company under certain conditions for the period of loss of earnings.

6. Services for education and participation

The various services for education and participation (BuT), also known as the education package, support children, teenagers and young adults from families who have little money. With these services, your child can take advantage of school and leisure activities if you would otherwise not be able to afford the costs.

7. Funding for daycare centers and childcare

If the parents or legal guardians cannot financially afford to stay in a day care center or day care center, the Office for Youth and Family Services has the option of having the costs covered in full or in part.

The amount of costs covered depends on the family's income.
